THE CARE CLINIC WAS FOUNDED TO ADDRESS THE NEED FOR PRIMARY AND PREVENTATIVE HEALTH CARE FOR PEOPLE WHO WERE UNINSURED AND UNDERINSURED IN SUMMIT COUNTY, COLORADO. IN THE FIRST YEAR OF OPERATION THE CARE CLINIC PROVIDED 294 VISITS. IN 2005, THE CARE CLINIC BECAME ITS OWN 501(C)(3) ORGANIZATION, AND IN 2006, THE CARE CLINIC MOVED INTO ITS CURRENT FACILITY IN THE MEDICAL OFFICE BUILDING, LOCATED BESIDE ST ANTHONY SUMMIT MEDICAL CENTER IN FRISCO. WITH THE EXPANDED CLINIC SPACE, THE CARE CLINIC WAS ABLE TO ADD BEHAVIORAL HEALTH (2006) AND ORAL HEALTH (2007) TO ITS MENU OF SERVICES. (CONTINUED IN SCHEDULE O)

THE CLINIC QUICKLY RESPONDED TO THE COMMUNITY NEEDS BY PROVIDING A SAFE OPPORTUNITY TO SEE PATIENTS WHILE REDESIGNING WORKFLOWS TO SEE PATIENTS WITH COVID SYSTEMS OUTSIDE OF THE CLINIC. NEW TECHNOLOGIES SUCH AS TELEHEALTH ALLOWED THE CLINIC TO SCREEN PATIENTS AND DIRECT THEIR CARE APPROPRIATELY. AS A RESULT, THE CLINIC WAS ABLE TO CONDUCT SIMILAR PATIENT VISITS TO 2019 WHILE PROVIDING THE EXTRA CARE OF COVID TESTING FOR THE COMMUNITY.

IN DENTAL, COVID-19 CAUSED THE CLINIC TO SHUT DOWN AND REDUCE CAPACITY OF DENTAL SERVICES FOR SEVERAL MONTHS WHILE EXTRA SAFETY MEASURES WERE IMPLEMENTED TO PROVIDE ASSURANCES FOR BOTH PATIENTS AND EMPLOYEES. THE CLINIC WAS ONE OF THE FIRST IN THE STATE TO OPEN BACK UP AND BEGIN TO SEE PATIENTS WITH LIMITED SERVICES. BY THE 4TH QUARTER OF 2020, THE DENTAL OFFICE WAS ABLE TO SEE PATIENTS AND PROVIDE ROUTINE SERVICES FOR THE COMMUNITY.

IN BEHAVIORAL HEALTH, IN-HOUSE CLINIC SESSIONS CONTINUED WHERE POSSIBLE IN 2020, WHILE TELEHEALTH TOOK ON AN INCREASED ROLE IN SERVICE DELIVERY. THE TRANSITION TO TELEHEALTH WAS FACILITATED DUE TO EXPERIENCE IN THIS AREA PRIOR TO THE PANDEMIC.

LAST, SCHOOL BASED HEALTH CARE WAS IMPACTED IN 2020 DUE TO A REMOTE AND THEN HYBRID MODEL FOR SCHOOLS. THE CLINIC ADAPTED TO THE NEEDS AS REQUIRED DURING THIS TIME WITH AVAILABILITY TO SEE STUDENTS AT THE MAIN CLINIC. OUTREACH WAS PROVIDED TO USERS OF THE SCHOOL BASED CLINICS TO ENSURE THAT INFORMATION WAS AVAILABLE REGARDING ALTERNATE OPTIONS FOR CARE.

FROM A FINANCIAL PERSPECTIVE, THE CLINIC WAS ABLE TO WEATHER THE IMPACT OF COVID19 WITH ADDITIONAL FEDERAL FUNDING FOR COVID TESTING, A PPP LOAN AND LOCAL GRANTS. THE CLINIC WAS ABLE TO MINIMIZE THE IMPACT TO EMPLOYEES DURING THIS TIME WITH A LIMITED FURLOUGH DURING THE SECOND QUARTER FOCUSING ON REDUCED HOURS. HOWEVER, THE CLINIC WAS ABLE TO BRING ALL EMPLOYEES BACK QUICKLY WITH THE HELP OF THE FUNDING PROVIDED.

ORGANIZATIONALLY, THE CLINIC REPLACED THE COO WITH THE DIRECTOR OF OPERATIONS, MISTY SHELL. IN ADDITION, THE HR DIRECTOR, PATTY PRICE, WAS PROMOTED TO THE CHIEF WORKFORCE OFFICER, FOCUSING ON HR INITIATIVES AND IT REQUIREMENTS FOR THE CLINIC. LAST, THE CLINIC PROMOTED THE GRANTS MANAGER, SUSAN ROBERTSON, TO THE CHIEF STRATEGY OFFICER. THIS SET THE STAGE FOR FOCUSING ON THE FUTURE NEEDS OF THE COMMUNITY FOR 2021 AND BEYOND.
